**Arrival Times and Arena Availability.** The warm-up and show arenas will be available starting Friday morning, June 5, 2010 through dusk. Arrival prior to Friday noon requires pre-approval of the Show Manager.

## Directions to the HorsePark

Woodside, California is about 30 miles south of San Francisco right off of I-280. It is located just north of Palo Alto and due west of Redwood City. The physical address of The Horse Park is 3674 Sand Hill Road, Menlo Park, CA 94025.

**From I-280**, take the **Sand Hill Road exit westbound** (that's away from the Bay). Head **up the incline** and immediately after **cresting the first hill**, The Horse Park at Woodside **entrance will be on the right**. The address is 3674 Sand Hill Road but that won't do you a lot of good as there aren't any address markers in the vicinity. If you go downhill for more than 500 yards after exiting 280, you've gone too far. The phone number at the Horse Park is (650) 851-2140. Oh, ***be careful of the bicyclists*** in the area as many of them don't understand the law of gross tonnage or comprehend the physics involved with stopping a loaded horse trailer going 50 mph in less than 100 feet.

**From Highway 101**, take **Woodside Road (Highway 84) westbound to Interstate 280**. Cross under the freeway and turn left (**southbound**) on **I-280**. Take the very next exit (Sand Hill Road) and head westbound away from the Bay. Head **up the incline** and immediately after **cresting the first hill**, The Horse Park at Woodside **entrance will be on the right**. The address is 3674 Sand Hill Road but that won't do you a lot of good as there aren't any address markers in the vicinity. If you go downhill for more than 500 yards after exiting 280, you've gone too far. The phone number at the Horse Park is (650) 851-2140. Oh, ***be careful of the bicyclists*** in the area as many of them don't understand the law of gross tonnage or comprehend the physics involved with stopping a loaded horse trailer going 50 mph in less than 100 feet.

If you're coming to the area **via Highway 92 (the San Mateo bridge)**, stay on Highway 92 until it **reaches I-280** and then **take I-280 southbound**. Continue southbound on I-280 about 10 miles and take the **Sand Hill Road exit**. Take the Sand Hill Road exit westbound (that's away from the Bay). Head **up the incline** and immediately after **cresting the first hill**, The Horse Park at Woodside **entrance will be on the right**. The address is 3674 Sand Hill Road but that won't do you a lot of good as there aren't any address markers in the vicinity. If you go downhill for more than 500 yards after exiting 280, you've gone too far. The phone number at the Horse Park is (650) 851-2140. Oh, ***be careful of the bicyclists*** in the area as many of them don't understand the law of gross tonnage or comprehend the physics involved with stopping a loaded horse trailer going 50 mph in less than 100 feet.

## Woodside Gaited Horse Show Rules and Regulations

1. ***Every class offered herein, is covered by either the rules and specifications of the current NWA, TWHBEA, SSHBEA or PFHA rule books and will be conducted and judged in accordance therewith.***
2. **THE WOODSIDE GAITED HORSE SHOW - SHOW COMMITTEE** reserves the right to itself to interpret all questions and conditions in regard to, or arising out of, or incident to, the show, without claims for damages or recourse of any kind. Exhibitors are notified that any act of discourtesy or disobedience by them or their riders, to the **JUDGES, SHOW STAFF OR OFFICIALS** shall disqualify their entry, and the owner shall forfeit their fees and other charges, including any and all prize money which they may have earned at the show. The Horse Show Committee shall have full power to act on any ruling in regard to such issues. Should the act justify it, the Horse Show Committee shall have the power to disbar the offending individual from further competition and to have them and their entire exhibition removed from the grounds without being held liable for damage of any kind. This shall be accepted as condition of entry. Any questions not covered in these rules and regulations shall be decided by the Horse Show Committee, consisting of the Horse Show Manager, the Horse Show Secretary and the Horse Show Steward.
3. **Registration and Membership Cards:** Tennessee Walking Horses must be registered with the Tennessee Walking Horse Breeders and Exhibitors Association (TWHBEA) or the IPWHR and be entered in their full registered name. Spotted Saddle Horses must be registered with the Spotted Saddle Horse Breeders' and Exhibitors' Association and be entered in their full registered name. Paso Fino Horses must be registered with the Paso Fino Horse Association (PFHA). Owners, exhibitors and handlers must be current members of their respective associations. Non-members of PFHA may join at the show in order to participate. Amateurs must have Membership Cards denoting such.
4. Horses must be entered and shown under their full registered name and registration number. Copies of both sides of the registration paper must be submitted with entry, except in cases of leased horses when only the front side of registration papers and a letter from the registered owner verifying this lease must accompany the entry.
5. Each person and/or exhibitor, by attending and/or participating in this horse event acknowledges that they understand the inherent danger that exists in riding and being around horses and the equipment used to handle them. As such, the Members, Officers, Directors and/or Committee Members of The Mounted Patrol of San Mateo County, the Mounted Patrol Foundation, as well as the TWHBEA, SSHBEA, CPFHA and PFHA, and The Horse Park at Woodside will not be held responsible for any loss, destruction, damage or injury of any kind to any horse, tack, vehicle, personal item, or any articles whatsoever nor for any injury suffered by any person while riding horses, by being around horses participating in this event, or as spectator.



6. Further, each exhibitor, trainer or owner of horses at The Horse Park facility will be responsible for any injury inflicted to another, spectator, visitor, or by any horse, equipment or vehicle owned or under the control of the exhibitor and shall Hold Harmless the Members, Officers, Directors and/or Committee Members of The Mounted Patrol of San Mateo County, the Mounted Patrol Foundation, as well as the TWHBEA, SSHBEA, CPFHA and PFHA, and The Horse Park at Woodside and will indemnify them in the event of a claim or legal action initiated against them resulting from the negligence of the exhibitor, owner, employee, trainer, agent, handler or representative of such horse, equipment or vehicle.
7. **ALL** owners and exhibitors will be held responsible for any damage or alterations incurred by them or their agents to barns or other The Horse Park at Woodside properties. IT IS STRICTLY FORBIDDEN TO REMOVE STALL DOORS.
8. Cruelty to or the abuse of a horse by any person at a recognized show is forbidden. Excessive use of a whip on any horse in a stall, runway, schooling area, show ring, or elsewhere on the show grounds before or during a show, by any person, constitutes a violation and renders the offender subject to penalty.
9. **Helmets:** All Sub-junior youth and any person riding in a class where there is a jump are required by law or PFHA rules to wear properly fastened protective headgear which meets or exceeds ASTM Standard for Equestrian use and carries the SEI tag. Exhibitors will supply their own equipment.
10. **The Horse Show Committee** reserves the right to combine classes, cancel classes, and to change the class schedule at any time. It is the responsibility of the exhibitor to check with the Paddock Master, Gatekeeper, or Show Office to keep informed as to when your classes will be conducted.
11. **The Horse Show Committee** reserves the privilege of substituting or changing judges if it becomes necessary. The judge's decisions in the show ring are their own responsibility and the Show Committee accepts no responsibility for these decisions.
12. **No entry will be accepted or back numbers released unless it is:**
  - a) Properly signed and, in case of a minor, signed by a parent or guardian. PLEASE NOTE: The entry form must be signed by all handlers, riders, owners, trainers, and drivers. No one may show a horse unless they have signed the entry blank entering that horse. Printed stamps and copies of signatures will not be accepted as a signature.
  - b) Made on an entry blank provided by the Show.
  - c) Shows correct mailing address of owner.
  - d) Accompanied by payment in full of ALL FEES.
  - e) Enclose copies of current TWH, PFHA and CPFHA membership cards. Exhibitors of PFHA horses MUST be a current member of PFHA or join prior to acceptance of entries at this show.

13. **Cancellation or Substitution of Entries.** Exhibitors canceling their entries for any reason after June 5, 2010 shall forfeit entry and stall fees. No substitutions of horses will be permitted. When exhibitors, trainers or stables wish to make a change in entries in any class, they are required to follow the procedure of scratching the existing entry and making a new entry with the Show Secretary's office. Credit will be given for the scratched class if done properly in the horse show office and another class added. Horses not properly scratched from a class and are not shown will forfeit their fee. Refunds of scratched or missed classes will not be made. In the event of the sale or injury to a horse (Veterinarian's Certificate required), exhibitors may post-enter another horse in the same class at no additional fee.
14. **ENTRIES IN ALL CLASSES/EVENTS MUST BE READY AND REPORT TO THE PADDOCK MASTER FIVE(5) MINUTES PRIOR TO THE START OF EACH CLASS/EVENT.** There will be a three(3) minute warning to appear and the gate will close two(2) minutes after the first horse enters the show ring for each class.
15. **Stabling: Stalls will not be available until after 12:00 noon Friday, June 4. ALL HORSES ENTERED IN THE SHOW MUST BE IN A STALL.** Stalls are 12 x 12 and have cement floors. Each owner to provide own water and feed buckets for horses. NO STRAW IN THE STALLS. SHAVINGS ONLY. Stalls must be vacated by 6:00 PM Sunday June 6, 2010.  
  
**First bedding will consist of 4 bags of shavings.** Additional shavings can be purchased at the show. Order forms available in the office. Cost of shavings can be added to exhibitor open check. All accounts must be paid and closed at end of show.
16. **Trailer In, Day Use:** Trailers must be parked in designated areas as directed by Barn Manager or Traffic Director.
17. No dogs or other pets will be permitted on the grounds unless under leash control of the owner. Any animals running free will be impounded and removed from the grounds.
18. Food and beverages will be available on the show grounds.
19. **PAYMENT:** Make checks that accompany entries payable to: **Mounted Patrol Foundation.**  
  
A signed open check must be left with the Show Office to cover all exhibitor expenses .after the initial entry blank is submitted. If the exhibitor does not close out their account at the end of the show, the Show Secretary will close out the check.

20. There will be a penalty of \$50.00 if a check is refused by the bank for any reason. No checks will be processed through the bank a second time, and must be covered by a money order, cashier's check, credit card or cash, in addition to the penalty. 22. **PRIZES** – A ribbon will be awarded to first through fifth place and classes will be placed to sixth places in Regular Classes and first through fourth place in Championship Classes. In Championship Classes a trophy will be awarded to the Champion.
23. The main show arena is The Bay View Arena and arena Footing is a combination of clay, sand and silt. There will be a warm up arena. The trail course will be set up in a separate arena.
